We were ordered out of Afghanistan in 2021 based on intel about the Taliban. Returning home, I worked as a corporate pilot.

My passion for learning has made research my main hobby over the last 55 years. As a pilot, I worked with, trained, and met thousands of people across America and worldwide. I discussed my solutions for America's problems with people who would tell me I should run for

political office. I feel compelled to run for office because America has become so divided. We must start working together to fix America's problems. We must elect people to office who can actually solve America's problems. Take a look at my reform ideas. Invite your family and friends to look at these ideas and have a conversation about them. Tax Reform

The federal government imposes more than 100 taxes and fees on Americans. Add state taxes, and it will take the average worker 6 months to pay their tax liability. Despite record revenue of \$13.4 trillion over the last 3 years, the federal government still added \$6.5 trillion to the federal debt. My Currency Usage Tax (CUT) eliminates all current federal and state revenue sources by replacing them with a single flat tax. Eliminating income and payroll taxes increases a worker's spending power and will give them greater opportunity to invest and save. Eliminating property tax means people can pay off their homes or businesses sooner, and the government no longer has the power to take property through taxation. Eliminating all small business taxes and fees affords them the opportunity to hire more people, pay better wages, and provide more goods and services. Eliminating corporate taxes will likewise allow corporations to hire more workers, increase salaries, improve inventories, and create more products at a lower cost. CUT eliminates America's convoluted and burdensome tax structure by returning to its Constitutional mandate of a uniform tax based on economic productivity. Utilizing a 1% tax on the U.S. Dollar Daily Funding Flows of \$7.5 trillion will produce a revenue stream of \$75 billion per day, equating to more than \$27 trillion annually. CUT is now the only way to pay off the \$34 trillion federal debt.

Welfare Reform

The federal government maintains 83 different welfare programs. Include every state program, and that number jumps to more than 600. Currently, over 200 million Americans receive some form of welfare support. Since 1935, our government has spent more than \$40 trillion on welfare and entitlement programs. The only time the poverty level dipped below 11% was in 2018 and 2019. My welfare reform replaces all federal and state programs, saving \$2 trillion annually. It is not welfare but a Supplemental Income Pay (SIP) that will match any job up to 40 hours per week and volunteer work up to 60 hours per week. SIP will match the federal minimum wage, including any state cost of living adjustment up to a maximum of \$78,300, the GDP per capita. My welfare reform immediately lifts the poor out of poverty and into the middle class without any conditional requirements.

Healthcare Reform

My healthcare system consists of seven distinct proactive programs, each serving a specific purpose and need. Every citizen is required to participate in Primary and Essential Healthcare. PHC handles outpatient care, and EHC covers inpatient care. People participate in Chronic Healthcare, Mental Healthcare, Assisted Living Care, Risk and Recovery Care, and Aesthetic Healthcare based on their specific needs. All USCF healthcare programs operate in the free market to create competition that improves quality while keeping costs low. Healthcare for children is integrated and funded through the school district where they live to have no premiums or copays. Once implemented, my healthcare reform can save \$1.5 trillion per year.
